



Exhibitor Liability Insurance Program

As a standard requirement for all our show exhibitors, it is necessary for you to carry general liability coverage from an insurance company in good standing with minimum policy limits of \$1,000,000 per occurrence and \$2,000,000 aggregate. Insurance Coverage is not optional.

This insurance must be in force during the lease dates of the event, August 22-26, 2022, naming Show Winners Corp dba The Water Expo and the Energy Expo (8900 SW 107 Ave., Ste 313, Miami FL 33176) as the certificate holder. The following must be named as additional insured: Show Winners Corp dba The Water Expo, the Energy Expo and Doubletree by Hilton Miami Airport Convention Center.

Show Winners Corp dba The Water Expo and The Energy Expo has requested that Rainprotection serve as their insurance management company. In addition to being able to provide exhibitors with insurance, we are also collecting and verifying that all insurance certificates, regardless of the insurer, are verified for compliance.
